5. I acknowledge that I am responsible for my own safety (and the safety of my possessions) while undertaking the Activities and have agreed to undertake the Activities without a guide.
6. In the unlikely event of an accident, or loss or damage to my personal affects, I acknowledge that the Company will not be liable for any direct or indirect loss, damage or injury arising from or in connection with the Activities (except for death or personal injury caused by the company's negligence) and I waive all and any claims against the Company in this respect.
7. I certify that to the best of my knowledge I do not have a medical condition which might have the effect of making it more likely that I be involved in an incident which could result in injury to myself or others. To the best of my knowledge I am not pregnant.
